

## ON THE ROAD FOR UKRAINE - LEGAL DISCLAIMER

Please read this disclaimer relating to the use of the Alpega services in the context of the Alpega campaign *On the Road for Ukraine*. The use of the Alpega Services in this context is subject to this disclaimer and the terms of the agreement concluded by Customer with Alpega relating to the use of Alpega's products and services (including the General Terms and Conditions <https://www.alpegagroup.com/en/tc-carriers/>). By using the Alpega Services in the context of this campaign, Customer agrees to and accepts all of the terms of this disclaimer. Furthermore, the obligations incumbent on Customer under the terms set herein apply to the Users of Customer. Customer represents and warrants that its Users agree to the terms of this disclaimer and Customer accepts full liability in case of non-compliance with these terms by such Users. If you are accepting these terms on behalf of a company or any other (legal or natural) person, you represent and warrant that you have full authority to bind that company or person to these terms. These terms will prevail over any conflicting or inconsistent term as mentioned in Teleroute or in the General Terms and Conditions as referred to above.

Any freight offer posted on an Alpega freight exchange platform in the context of the campaign *On the road for Ukraine*, as well as any data related thereto, are shared by Alpega with Customer at the request of a third party, which is not a customer of Alpega (*association, organisation or any other legal or natural person involved in the Alpega campaign On the road for Ukraine*) (hereafter the "Third Party"). These data are provided strictly for the purposes of this campaign whose details have been notified to Customer. The services provided by Alpega in this context are therefore offered as an exceptional measure, strictly for humanitarian purposes, and are limited to the sharing of data related to a specific freight offer communicated by a Third Party (*posting of the freight data and sharing of data relating thereto*), for said purposes. Alpega does not represent the Third Party and shall not be involved in any way whatsoever in any transaction or arrangement that Customer may conclude with the Third Party in relation to said offer. These will be concluded and the services performed at the sole risks of Customer.

Customer acknowledges and agrees that:

- Alpega may share the personal data of Customer with the Third Party in the context of and for the purposes of the campaign *On the road for Ukraine*, following any interest notified by Customer;
- Alpega has no control over and shall not warrant the reliability of the Third Party and the quality, safety, lawfulness or legal aspects of its intentions and activities, the data that it communicates to Alpega and the transaction/arrangement that it may conclude with Customer in relation thereto; while Alpega may take certain measures with the aim of avoiding potentially illegal actions in the context of these exceptional services, Alpega assumes no liability or obligation to take any such measures or actions; Customer is sole responsible to make its own enquiries and verifications with respect to the data of this offer, the Third Party and its intentions and activities;
- Alpega disclaims all representations and warranties of any kind (express or implicit) and will bear no liability in relation to this offer, the Third-Party and any transaction that may be arranged with it (including but not limited warranties relating to the accuracy, legality, correctness, integrity, truthfulness and reliability of the data, the freight related thereto and the intentions and activities of the Third Party); Alpega does not warrant that the Third Party shall comply with the applicable laws and regulations and that any transaction/arrangement concluded with the Third Party may not cause Customer to violate any applicable laws and regulations;
- Alpega shall not provide any service other than sharing the data received from the Third Party with Customer in relation to a specific freight offer; Other services (including but not limited to debt mediation service, any payment related service, ...) are excluded in relation to said offer; Alpega shall not in any way be responsible for assisting Customer in any manner with the provision of the services and the enforcement of any obligation, which have been agreed with the Third Party.
